## NOTIFICATION

Whereas Notification under section 117 of the Motor vehicles Act. 1988 was issued vide No. SML-Reader/ADM(716)/2007-234-250 dated 18<sup>th</sup> April, 2007 vide which long Route buses coming from Solan side were diverted to bye pass Road and from Bilaspur side were allowed to take turn from Victory Tunnel for smooth plying of heavy and Light vehicles on Cart road on trial basis. This was subsequently confirmed vide this office order No. SML-Reader/ADM(716)/2007-1284 dated 30.8.2007.

And whereas it has been observed, that General Public are facing great hardships, as local buses are not available to carry the passengers who are disembarked at Tutikandi bus stand. This fact has also been admitted by the HRTC Authorities also. Therefore, this experiment has failed to achieve the fruitful purpose is not in public interest.

Now, therefore, I, J. S. Rana, IAS, District Magistrate, Shimla in exercise of the powers vested in me under section 117, of the Motor vehicles Act. 1988 and all other powers enabling me in this behalf withdraw the notification dated 18-4-2007, subsequent Notification date 30.8.2007 & old practice be restricted to the extent of following one way traffic regulation on the Circular road/Cart road in the larger public interest.

These orders shall come into force from 1<sup>st</sup> July, 2008.
